- 4/1/2020 – All proposed changes are drafted and circulated to the committee;
- 5/1/2020 – Deadline for the committee to make recommendations to the court;
- 6/1/2020 – Deadline for the court to consider the proposed amendments and prepare any response;
- 7/1/2020 – Proposed rule changes posted for comment;
- Comment period concludes 60 days after posting; and,
- 12/1/2020 – Changes to the proposed rules will be adopted.
